The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Agni College of Technology, Old Mahabalipuram Road IT Highway, Near Navalur Thalambur, Kancheepuram District, Chennai-603 103, Tamil Nadu** as a whole.
