  - iii. Additionally Audited Financial Statements for last 3 Financial years.
3. Reservation Policy of the Central Government (Including EWS) / Respective State Government/ UT as the case shall be applicable to all the Programmes. The concerned State Government/ UT Admission authority shall decide Modalities of Admission.
4.
